 - I. Holistic Student Support: D. McDermont, Director of Holistic Student Support
 - i. Talk about Holistic Student Support at the College, history of advising and evolution to current model with Student Support Advisors (SSAs) and "Case Management" approach
 - Question/comment: what is case load for an SSA?- Response: varies high as 475, dropped during covid, most around mid-200s, four within 300s - 200-250 is manageable, original plan ~150
 - Question/comment: how many SSAs Response: 12 SSA with about 215-220 students per SSAs
